

What we do at Little Gate Farm...

Little Gate Farm is a registered charity, that was born out of a vision to enrich the lives of learning disabled and vulnerable children and adults, equipping them with skills to improve their wellbeing and better their future.

Little Gate Farm is a 46 acre farm, that is half pasture and half ancient and semi-ancient woodland, in East Sussex high weald area of outstanding natural beauty. It has been owned by the Cordell family since the 1960's as predominantly a sheep farm, but now, Little Gate Farm is home to an array of different farm animals and wildlife and is the ideal place to learn new skills.

Work trainees

Learning disabled adults that come to the farm are called our Work trainees. The farm work trainee program offers Learning Disabled adults the opportunity to gain new skills and grow in confidence. Our Work trainees gain work experience whilst looking after the farm, caring for animals, making craft and working on our horticulture project to grow and cook their own produce. We also work in the woodland, learning how to manage it and conserve the wildlife and work trainees learn how to use traditional methods to make woodland products.

Supported Employment

Helping Learning Disabled adults into employment is the main focus of our work at Little Gate Farm. We know that work brings financial benefits and improves self-esteem, physical and mental health and friendship.

We offer a Supported Employment Programme for Learning Disabled Adults. We work closely with Employers and with Learning Disabled adults and their families to find appropriate job opportunities in the local area. Our Employment Support Workers help Learning Disabled adults in the workplace until they are confident enough to work independently.

We do not rush this process and during their time at the farm each individual work trainee will work towards goals and develop both practical work skills and personal qualities that are individual to them and are linked with their own interests and career aspirations.
